

Tjaarda 483 Breeding Contract for 2018

This 2018 contract is for breeding to the KFPS/FHANA registered Friesian stallion Tjaarda 483 Sport, standing at the Friesian Connection Stallion Station. This agreement is valid only for the 2018 breeding season. Mare owner and the FC Stallion Station agree to the following terms and conditions:

1) BREEDING: The FC Stallion Station stands the Friesian stallion known as Tjaarda 483. Semen shipped is to be used on only the mare provided in this agreement. This agreement cannot be transferred or sold by the mare owner. There shall be no right of return to the stallion if the mare is sold or otherwise changes ownership.

2) BREEDING FEE AND BOOKING FEE: The Breeding Fee for Tjaarda 483 shall be \$1000. This includes a non-refundable booking fee of \$500 payable with this Agreement, which reserves in the Stallion's book for 2018 a breeding for the Mare. MARE OWNER agrees to pay the balance and any other fees due before any shipment of semen shall be made.

3) BREEDING SEASON: The FC Stallion Station's 2018 breeding season for Tjaarda 483 is from March 1 to September 14, 2018. Cooled semen will be available in the order contracts have been received. Advanced booking will place your mare at the top of the list for shipped semen. All other semen requests will be on a first come basis.

4) COOLED SEMEN ORDERS: For semen to be collected and shipped for timely arrival, semen must be ordered the day before the intended insemination and before 4:00 PM Eastern Time for shipment within the USA. Orders for shipments into Canada must be made by 8:00 AM Eastern Time the day before intended insemination. Canadian shipments require a USDA Federal Veterinary seal and extended time is needed to fulfill CFIA requirements.

Requests for semen are to be made to the stallion managers. A message can be left on the telephone. Messages are checked several times a day. Advance requests can also be made by text, fax or e-mail. Confirmation of the order of semen will be given via email. Please do not call between 10:00 PM and 6:00 AM Eastern Time. **We are closed on Sundays.**

The stallion managers must receive reasonable notice of desired collection and shipment dates. Mare owner is to advise stallion manager upon start of the mare's cycle and contact the stallion manager again the day of the desired collection and shipment. The stallion manager cannot guarantee shipment on the desired date without this information. Semen for Tjaarda 483 can be shipped five days a week (Monday through Friday).

The mare owner will be responsible for all costs involved in collection. Orders canceled after the stallion has been collected will be billed in full. The FC Stallion Station assumes no responsibility for the loss of semen or semen viability caused by the carrier (FedEx). There will be no shipment on Saturdays, Sundays, holidays or the day before a holiday.)

Mare owner understands that each shipment of semen will contain one dose of semen. A second dose will be included in the shipment only after all orders are filled and additional doses are still available. Priority

will be given in the order the contracts were received. To insure your place on the top of the list, we encourage you to return this contract with payment in full early.

Fees for shipped semen are detailed in our 2018 mare reproductive services and boarding price list. (page 4 of this contract)

5) FOR ON-SITE BREEDINGS: Reproductive services are available at the FC Stallion Station. Fees for Mare Cycle Management and board are detailed in the 2018 Mare Reproductive Services and Boarding Price List. (page 4 of this contract) Services rendered on the farm for the guest mare will be charged to the mare owner. Additional services available include veterinary palpating, ultrasound, Histrelin injections, Lutalyse injections, Oxytocin injections, uterine lavage, Regumate, uterine cultures and biopsies, etc. In addition to reproductive health care; deworming and farrier services will be available. All costs will be passed on to the mare owner.

The breeding fee, 1st month's board and 1st mare cycle management fee must be paid upon the mare's arrival to our farm. All remaining mare care expenses must be paid for at time of mare's departure.

Mare shall be of healthy and sound breeding condition. A veterinarian health certificate and uterine culture and biopsy are recommended on all but maiden mares. All guest mares must be vaccinated for Tetanus, Encephalomyelitis (Eastern and Western), Equine Influenza, Rhino, West Nile and Potomac Horse Fever and dewormed prior to arrival on farm. FC Stallion Station will offer EVA vaccine (ARVAC, Zoetis) for all guest mares at no cost to the mare owner. Farrier services will be available as needed. Recent coggins required. **Please note that a significantly overweight or underweight mare is difficult to get in foal. Therefore, it is recommended that mare owners address body weight issues prior to breeding their mares.**

Guest mares for Tjaarda 483 will be bred by artificial insemination and will be stabled at the Janice VerMerris division of the FC Stallion Station – 2872 – 144th Ave. Dorr, Michigan. Guest mares for all other stallions standing at the FC Stallion Station will be bred and stabled at the Amy Kroll division of the FC Stallion Station – 2685 – 144th Ave. Dorr, Michigan.

6) LIVE FOAL GUARANTEE: Should the Mare fail to conceive, abort, die or not produce a "Live Foal" (Live Foal shall be defined as a foal that stands and nurses without assistance for a period of at least 24 hours from the time of birth) then the Stallion Station guarantees the Mare Owner shall have the right to rebreed or substitute a mare (upon the approval of the Stallion Station) within the current or the following breeding season only.

Mare Owner shall notify Stallion Station within sixty days of the last day of Breeding Season if the Mare did not conceive to be eligible for a rebreed. Mare Owner shall also notify Stallion Station within thirty days of the Mare's abortion, should the Mare abort.

If the Mare does not produce a "Live Foal", then the Mare Owner shall provide the Stallion Station with a veterinarian's certificate stating the time and date of birth, time and date of death and cause of death within seven calendar days of such death.

In the event that the mare dies, Mare Owner shall provide the Stallion Station with a veterinarian's certificate of death.

Live Foal Guarantee shall be specifically conditioned upon Mare Owner's vaccination of Mare for Rhinopneumonitis in the 5th, 7th, and 9th month of the Mare's pregnancy. Mare Owner shall provide the Stallion Station with the certificate stating that such vaccination has taken place at the time the Mare Owner requests a rebreed pursuant to this section.

Live Foal Guarantee shall lapse and the Stallion Station/Owner shall have no further obligation under this section if:

1. Mare Owner fails to rebreed Mare during the acceptable return breeding periods as defined in this section. (within the current or the following breeding season)
2. Mare Owner fails to provide Rhinopneumonitis vaccinations certificate.
3. Mare is bred by another stallion without written consent by the FC Stallion Station.
4. Mare is substituted with another mare without written consent by the FC Stallion Station.
5. Mare fails to conceive, aborts or dies and Mare Owner fails to notify Stallion Station as defined in this section.
6. Foal dies due to lack of supervision or proper facilities during birthing process.
7. Foal dies due to any negligent act of the Mare Owner.

If Mare does not become pregnant within two breeding seasons, Mare Owner no longer has the right to rebreed Mare to this stallion and forfeits all fees paid to the Stallion Station.

The Live Foal Guarantee in this contract is non-transferable and non-assignable and should the Mare be sold or otherwise disposed of prior to the birth of the foal, the live foal guarantee shall be void.

Mare owner shall not be entitled to a refund of fees paid except if the stallion should die or become unfit for service prior to serving the mare in the present breeding season. Once the mare has been serviced, there will be no refunds of any kind. Should the stallion die after the mare has been serviced, the live foal guarantee becomes void.

7) The FC Stallion Station cannot be held responsible in any way for any illness or injury to a mare or to any other horse due to breeding to stallions of this company, nor for a mare's failure to conceive. It is understood that the breeding farm, its employees, veterinarians, and guests shall not be liable for any injury, escape, disability, or death of any horse on its premises. The mare owner, whose horse(s) are under the care of the breeder, will not be liable or responsible for any damage, injury or death to the breeding farm employees, veterinarians, or other animals in the care of the breeder, whether or not caused by his horse. Under Michigan law an equine professional is not liable for an injury or the death of a participant in equine activities resulting from the inherent risks of equine activities.

8) Mare owner should have their mare checked for pregnancy at approximately 15 days after ovulation. This allows for time to handle any issues around possible twin embryos as well as give the mare owner and the FC Stallion Station time to prepare for the next breeding cycle if the mare did not settle.

9) Birth announcements for 2019 foals are to be recorded on line via the KFPS website using your KFPS log in and Password.

10) The laws of the State of Michigan govern this contract. All accounts are payable in U.S. dollars.

11) Mare owner acknowledges full agreement with this breeding contract by signing and returning this contract to the FC Stallion Station. Mailed, faxed and emailed signed copies are all acceptable and binding.

Please fill out all mare and owner information and return this contract to the FC Stallion Station. Be sure to make a copy for your records.

Shipped Semen (within the USA)	Semen collection, evaluation and packaging for shipment. Price quoted is PER SHIPMENT/PER MARE shipped to. A single collection which is processed for multiple mares will be billed at the stated rate for each mare. Stallions are collected Monday – Friday (except holidays and the day before a holiday) in the late afternoon or early evening with delivery the following day. No same day shipments. Any additional veterinary services will be billed separately at cost. Should the mare require management/breeding beyond the first cycle, subsequent cycles will be billed at the quoted discounted rate. Foal heat mares will not be bred unless foal is at least 10 days old. Frozen semen use is limited to mares age 4-12 years of age that have had at least one successful pregnancy and have no obvious reproductive problems. Equine Viral Arteritis for Tjaarda 483

Thank you for your interest in Tjaarda 483. At the Friesian Connection Stallion Station Inc., we have tested all our stallions for equine arteritis viral infection. The stallion Tjaarda 483 has been confirmed as a carrier of the virus in his semen. This carrier status may or may not be temporary and we will have Tjaarda retested periodically. All the other stallions at our stallion station have been confirmed negative and have been vaccinated to insure they will never become carriers of the virus in their semen.

You can safely breed a mare to a stallion that sheds this virus in his semen by adopting a couple of simple precautions.

Facts about Equine Viral Arteritis

Equine arteritis virus is a viral infection of horses that can affect both respiratory and reproductive systems. The virus is the cause of a disease termed equine viral arteritis (EVA). This virus is present in horse populations in many countries throughout the world; and as high as 80% of adult horses of certain breeds in some European countries and a similar percentage of adult Standardbreds in the USA are seropositive for antibodies to the virus. Exposure of susceptible horses to EVA may result in clinical or subclinical infection (an absence of any clinical evidence of disease). **The vast majority of cases of infection are not associated with the development of clinical signs of disease.**

Exposure of a horse to the virus for the first time is followed by an incubation period of 3-14 days before onset of the acute phase of the infection. Cases of EVA may present with all or any combination of the following clinical signs: fever, depression, loss of appetite, discharges from the nostrils and eyes, and swelling of the legs and perhaps other dependent parts of the body. Exposure of pregnant mares previously uninfected with the virus may result in abortion. It should be emphasized that horses affected with EVA invariably make uneventful clinical recoveries without any medical treatment. **Furthermore, susceptible (seronegative) mares only shed equine arteritis virus during the acute phase of the infection and cannot later become carriers of the virus.**

Two of the most common routes of infection with this virus are via the respiratory tract and by stallions that shed virus in their semen. No detectable reduction in fertility has been observed in carrier stallions or in mares to which they have been bred naturally or by artificial insemination,

using fresh cooled or frozen semen. You can safely breed a mare to a stallion that sheds this virus in his semen by adopting these simple precautions.

Guidelines for Breeding a Mare to an Equine Arteritis Virus Shedding Stallion

Prior to breeding your mare:

Mare should be tested for serum antibodies to equine arteritis virus. A blood sample can be submitted to any veterinary medical diagnostic laboratory approved by the USDA to carry out the test for this infection.

Mares that test **antibody negative** can be classified in **Category I**. Proceed as follows:

Category I Mares

1. If the mare is not pregnant, she should be vaccinated against EVA as soon as possible. The only vaccine currently against EVA is a modified live vaccine (ARVAC® , Zoetis), which has been shown to be completely safe for use in stallions and non-pregnant mares. It is not recommended for use in pregnant mares in their last trimester.
2. Mare(s) that are vaccinated should wait to be bred to an EVA shedding stallion for 21 days. This period of time is required for a mare to build up adequate protection against the virus following vaccination.
3. Foaling mares can be vaccinated as early as 10 days postpartum.
4. Once 21 days have elapsed after vaccination, your mare can be bred to an equine arteritis virus shedding stallion. There are no more restrictions or need to isolate, even if the mare needs to be rebred to the EVA shedding stallion in subsequent cycles.

Category II Mares

Mares that test **serologically positive** for antibodies to equine arteritis virus can be classified in **Category II**. **You can proceed with breeding these mares to a shedding stallion without the need for prior vaccination against EVA or isolation from other horses after breeding.** Being serologically positive for antibodies to equine arteritis virus means the mare already has protection from the virus in her body.

Some mare owners may choose to forgo the testing and vaccinating of their mare(s) and just breed their mare to an EVA shedding stallion. These mares are then exposed to the Equine Arteritis Virus which may result in a clinical or subclinical infection. While this is not the recommended procedure, if chosen, it is extremely important to isolate the mare(s) for 21 days after breeding. Breeding an unprotected mare to an EVA shedding stallion will not affect the fertility of the mare being bred. However, even if she shows no symptoms of EVA, she will likely be shedding the virus and any unprotected pregnant mares in the vicinity of the bred mare are at risk of aborting. After being bred to an EVA shedding stallion, mares will likely become serologically positive for antibodies to equine arteritis virus due to natural immunity from exposure to the virus. This will then put them in category II with no restrictions in the future when breeding to an EVA shedding stallion.

Purchaser must provide Stallion Station with a credit card number which Purchaser hereby authorizes Stallion Station to bill directly for all fees incurred in connection with this Agreement.* The Stallion Station reserves the right to refuse to perform any service under this Agreement except upon its receipt of authorization of applicable charges to the following account with respect to which Purchaser is an authorized user: *Purchaser agrees not to contest any charge made pursuant to this Agreement on the basis that the Mare failed to produce a live foal or otherwise become pregnant. **If Purchaser does not wish to have a credit card on file with the Stallion Station to bill shipping and handling expenses to, then, in addition to the \$1000 breeding fee, an “Additional Service Fee Deposit” of \$1000.00 paid by check or money order which Stallion Station shall hold on Purchaser’s account and from which Stallion Station shall be permitted to deduct directly all Additional Service Fees as incurred.** The Stallion Station shall refund to Purchaser any unused balance of the Additional Service Fee Deposit within forty-five (45) days of the close of the current breeding season.
